According to Article 28 of the University Act and Article 38 of the Junior College Act, students' schooling and other affairs relating to students' status shall be listed in the academic rules of universities and then reported to the Ministry of Education for future reference. However, if the authorities of educational institutions confirm that an event affecting normal learning occurs, a university may evaluate the circumstances of each individual case and then leniently implement a proper and flexible mechanism of university study to help students overcome the obstacle.

因應新型冠狀病毒肺炎持續延燒,教育主管機關認定屬影響正常學習與就學之事件,為使學生安心就學,避免因無法如期返校而影響就讀權益,得依本「因應新型冠狀病毒肺炎疫情學生安心就學措施」提供彈性修業機制,專案簽奉校長核准,以即時因應提供協助。

In response to the epidemic of novel coronavirus, the authorities have confirmed that this epidemic is an event affecting normal learning and enrollment. In order to facilitate students' normal learning and enrollment and avoid the negative impact on their right to education due to their being unable to arrive at NCU in time, NCU provides a flexible mechanism of university study according to "Measures to Facilitate Students' Schooling at NCU in Response to the Epidemic of Novel Coronavirus." The president of NCU has approved the measures in order to provide timely assistance.
